3 FOR the purpose of requiring the Department of Transportation and local 4 governments, in developing a construction or improvement project involving a 5 bridge that or other transportation facility that is adjacent to or crosses a 6 waterway, to incorporate, to the extent feasible, consider any reasonable and 7 appropriate measures to provide or improve certain water access for certain 8 activities; requiring the Department and local governments, in consultation 9 with certain entities, to establish certain inventories of certain bridges and 10 approaches to bridges; requiring the Department and local governments to review certain bridge construction and improvement projects to determine 11 which of the projects can safely and reasonably incorporate the provision of or 12 improvements to water access for certain activities standards and guidelines for 13 identifying appropriate transportation facilities for certain water access and 14 15 best practices and cost effective strategies to accommodate certain water access; and generally relating to the incorporation of water access considerations into 16 17 construction or improvement projects involving a bridge transportation facility.
